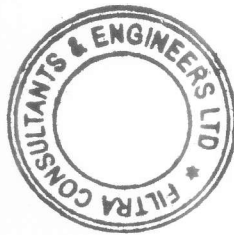

1. **Reason for change:** Re-appointment for a further period of three years commencing from April 1, 2018 till March 31, 2021, subject to the approval of Members at the ensuing General Meeting of the Company.
2. **Date of appointment:** Re-appointed in the Board Meeting dated March 8, 2018 w.e.f. April 1, 2018.
3. **Term of appointment:** Three years commencing from April 1, 2018 till March 31, 2021, not liable to retire by rotation, subject to the approval of Members at the ensuing General Meeting of the Company. The powers, duties, responsibilities and other terms and conditions of the existing Agreement remain unchanged except, the maximum remuneration has been increased from Rs.67.20 Lakhs to Rs. 84 Lakhs per annum payable monthly.
